Že veste? Ne čakajte z učenjem slovenščine, saj bo v skladu z veljavno zakonodajo:

- od 28. 10. 2023 do 1. 11. 2024 v postopku podaljšanja dovoljenja za začasno prebivanje za polnoletnega družinskega člana tujca treba predložiti **potrdilo o udeležbi v programu učenja slovenskega jezika in spoznavanja slovenske družbe**
- od 1. 11. 2024 pogoj za podaljšanje dovoljenja za začasno prebivanje za polnoletnega družinskega člana tujca **opravljen preizkus znanja slovenščine na ravni A1** in
- od 1. 11. 2024 pogoj **opravljen preizkus znanja slovenščine na ravni A2** za pridobitev dovoljenja za stalno prebivanje

GOALS OF THE PROGRAM:

- **learning** Slovene language to find employment, work and live more easily
- **getting to know** local culture, habits and everyday tasks
- **socializing**, forming mutual relations

CONTENT OF THE PROGRAM:

- **Personal identity** (how to introduce yourself)
- **Family and home** (relationships, customs)
- **School and kindergarten** (communicating with caregivers and teachers, helping children)
- **Physical activity and healthcare** (health services)
- **Food and drink** (in the store, at the marketplace)
- **Occupations and employment, unemployment** (explanation of employment options)
- **Public and other institutions and support networks**
- **Leisure time and hobbies** (cultural institutions, activities for children)
- **Purchasing goods** (shops, prices, units of measurement, clothes and shoes)

Don't wait. You can join any time, attending once or on multiple occasions.

Did you know? Don't wait to learn Slovene as it will be required by current legislation:

- from 28 October 2023 to 1 November 2024, in the process of extending a temporary residence permit for an adult family member of a foreigner, **a certificate of participation in a program of learning Slovene language and becoming familiar with Slovene society will be required**
- from 1 November 2024, the renewal of a temporary residence permit for an adult family member of a foreigner is subject to **passing a test of Slovene language proficiency at the A1 level**, and
- from 1 November 2024, a condition for obtaining a permanent residence permit will be **passing the Slovene language proficiency test at the A2 level**
